- 2. District Magistrate of the concerned district will be the Appointing Authority for the personnel to be engaged for the Child Helpline Unit at the DCPU and the Child Helpdesk at the Railway station located in the district except Kolkata.
- 3. In case of Kolkata, Director, Child Rights & Trafficking, W.B. will be the Appointing Authority for the personnel to be engaged for the Child Helpline Unit at DCPU, Kolkata and the Child Helpdesk at the Railway Station and the bus stands located in Kolkata.
- 4. For the position of 'Child Helpline Administrator' for WCD Control Room, Director, Child Rights & Trafficking, W.B. will be the Appointing Authority.
- 5. All the qualifications and experiences must have been completed on or before 07.08.2023.
- 6. Viva voce and computer test will be held at the district level on the same date throughout the state or on the date fixed by the selection committee of the concerned district. Any request for change of date from the applicants will not be entertained.

The willing candidates may apply in prescribed application format through **online portal only** available in the website of Department of Women & Child Development and Social Welfare, Government of West Bengal, www.wbcdwdsw.gov.in Application, if done in other mode except online portal, will not be entertained. Scrutiny of applications and verification of documents and issue of Admit Card to the eligible candidates will be done at the concerned district end. For the positions under Kolkata district and WCD Control Room, scrutiny of applications and verification of documents and issue of Admit Card to the eligible candidates will be done from the end of Directorate of Child Rights and Trafficking.

Date of start of submission of online application is 7th August, 2023 and last date for submission of online applications 21.08.2023 up to 6.00 p.m.

The decision of the Selection Committee regarding all matters relating to the selection process shall be final.
