3. Engagement of personnel for Child Helpline (CHL) Unit at the DCPU will be done by the District Level Selection Committee of the district as constituted vide memo no 40 (Secy)-SW/O/ JJA-57/17 dt 30.01.2018 of Women and Child Development and Social Welfare Department, Government of West Bengal.

4. All the qualifications and experiences must have been completed on or before 01/02/2024.

5. Viva voce and computer test will be held on the date fixed by the District Level Selection Committee. Any request for change of date from the applicants will not be entertained.

The willing candidates may apply in prescribed application format through online portal only available in the website of Department of Women & Child Development and Social Welfare, Government of West Bengal, https://wcdsw.wb.gov.in/dcrt/.Application, if done in other mode except online portal, will not be entertained.
